TRUST DEED

TRUST DEED OF GAUTAM SOCIAL AND EDUCATIONAL TRUST

This declaration of trust is made in the city of P.O.-Pakaria, P.S. Shambhuganj, Registry office and district-Banka on this the \*\frac{2\text{NTJolo}}{2\text{day}}\text{ day of July 2010 by sri Manwendra Kumar Gautam, Age-33 years, S/o sri Krishna Singh, resident of village and P.O.-Pakaria, P.S. Shambhuganj, Registry office and district-Banka.

herein after called the settler transferring the awnership of the properties in Schedule-A to the corpus of the trust called "GAUTAM SOCIALAND EDUCATIONAL TRUST" hereby declares to the ownership of the trustee appointed under this deed.

And whereas the trustees appointed hereby have expressed their consent to be vested with the ownership of the subject matter of thes trust and have accordingly taken possession of and assumed the legal ownership over the said properties.

And whereas with a view to secure proper and permanent administration of the trust, it is considered advisable to execute a formal deed of trust specifying the terms and conditions of such administration and also the power of the trustees.

## NOW THIS DEED THEREFORE WITHNESSTH AND IT IS HEREBY DECLARED BY THE SETTLER:

- The name of the trust shall be "GAUTAM SOCIAL AND EDUCATIONAL TRUST" however, the trustee may carry on the charitable activity under any other name from time to time.
- That there shall not less than two and not more than three trustees at any time who togather shall constitue the board of trustees, the following shall be the first trustees:
  - a. Smt. Nitu Kumari Age-34 years, w/o Sri Manwendra Kumar Gautam resident of Pakaria. P.S. Shambhuganj, District-Banka,
  - b. Sandip Kumar Singh Age-37 years, S/o Sri Sudhir Prasad Singh resident of Vill+P.O. Parsando Havli-Kharagpur Distt, Munger.

## The governing body of the trust shall be as follows:-

<u>President-</u> Smt. Shalini Singh, Age.-34 years, D/o sri N.K. Singh, address:-TR-Type Bistupur, Jamsedpur (Jharkhand)

<u>Secratory-</u> Smt. Nitu Singh, Age.-34 years, w/o Sri Manwendra Kr.Gautam, at-Pakaria, P.s.-Shambuganj, Distt.-Banka.

<u>Treasurer-</u> Sri Sudhir Kr. Singh, Age.- 59 years, S/o late Asheshwar pd.Singh, At+P.o-Parsando, via-Haweli-Kharagpur, Distt.-Munger.

The board of trustee may select, appoint and co-opt one or more trustees, including a trustee in the event of death of any trustee, provided the number of trustees on the board any time shall not exceed three.

4. The trustees shall be entitled from time to time open and maintain bank accounts in any scheduled or private bank and such bank account may be operated by any of the trustees and by the persons as may be authorized by trustees from time to time.

IT IS HEREBY DECLARED THAT THE TRUSTEES SHALL UTILISE AND APPLY THE INCOME ARISING FROM THE TRUST FUND FOR THE BENEFIT IRRESPECTIVE OF THE CASTE, CREED OR COMMUNITY ON ALL OR ANY ONE OR MORE OF THE FOLLOWING CHARITABLE PURPOSE:

- To open, run, continue an educational and vocational school or institution.
- To engage teachers, professors, instructors, and experts able to import efficiently instruction to pupils and students in modern societies, industrial avocation, research work, intellectual and other pursuits.
- To develop mental, physical and moral uplift of the students so as to make them good citizen.
- To establish, maintain and run a boarding house and resi dential institutions for and for those connected with the institution.
- To invest, dispose of transfer, and otherwise deal with the subject matter of trust in such manner as trustees should deem fit so as to enable the society to carry on the ob jects of the trust effectively.
- To accept donations, grants, presents and other offerings and to deal with the same for the trust.
- vii) To charge moderate tuition fees and otherwise recoup themselves for the outlay and expenses incurred in the keep up and maintenance of institutions established or about to be established under this deed.
- viii) To encourage sportsman and adventures spirit in the pupils and those connected with the institution.
- To develop disciplinary conduct and a habit to observe the rule of law and self restraint.
- To lease out the property of the trust to any charitable educational institution having the objects identical to the trust with a condition that at least two trustees of the trust shall be part and partial of the management com mittee of the educational institution for the benefit of the trust property.

- xi) To provide scholarship to the needy and deserving stu dent having the good academics and belong to the poor community for the upliftment of the society.
- The head office of the trust shall be at -Pakaria, P.S.-5. Shambhuganj, District-Banka.
- 6. The trustee may at any time, if consider it necessary for the benefit of the trust, raise or borrow money for the use and benefit of the trust on such terms and conditions on securities of movable and immovable proper ties of the trust as they consider proper.
- 7. The trustees shall invest the trust funds in approved funds.
- 8. That it is agreed and declared that no part of the trust fund shall be utilized by the settler or trustees for their own purpose nor they will be entitled to borrow the funds of the trust by any rate.
- 9 That the trustee may resign from the trustee ship and the trustees in that meeting are empowered to eccetp the same.
- That the trustees are empowered to fill up the casual 10. vacancy in the board of trustees.
- That the trustees shall maintain true and fair accounts of 11. all the receipts and payments of the trust and accounts so maintained shall remain at the office of the trust.
- 12. That the accounting year of the trust will be from 1st April 31st March every year and the first accounts shall be closed on 31st March 2011.
- That the trustees are empowered to appoint a chartered 13. account for the audit of the accounts of the trust yearly and to fix their remuneration of such auditors.
- That the trustees shall meet every quarter for the purpose 14. of the trust and for the management of the trust and its funds.
- 15. That the funds collected for the trust shall be utilized for carrying on the objects of teh trust or acquiring the capital assets or constructing the building etc. for the purpose of the trust.

- 16. That the trust deed can be amended by 2/3 majority of the trustees in a meeting specially called for the purpose by giving 14 days notice for the purpose and the resolution passed by such majority as circulated with or without noti fication shall be final and binding for good for this deed.
- That the trust can wound up its affairs if it finds it difficult to run the activities of the trust any more but no part of the funds of trust and property shall revert back to the trustees.
- That in case the trust decided to wind up its activities it may handover the corpus of the trust its assets and liabilities to another trust or society having same or similar ob jects.
